Who is entitled to extra leave pay?

The Extra Leave Pay Collective Agreement only applies to IG BAU members employed by a guild enterprise. You are entitled to the extra leave pay after six months of employment with the company.

The leave pay will be paid in addition to holiday wage only in connection with leave taken. An IG BAU office near you will issue a certificate of your IG BAU membership.

Of course, the collective agreement also applies to marginally employed persons and trainees.

If your wage group is not shown in the examples below, please contact your nearest IG BAU office. We will be happy to help you with the correct calculation of your extra leave pay.
